2. Rationale:

a. Need for the change: Currently, students in the music programs enroll in ensembles for credit (1) by enrolling in Ensemble I - VIII, or for zero credit by enrolling in courses titled by the ensemble's name, for example, Concert Choir hegis number 10040800. We wish for the student to continue to have the option for 1 credit or 0 credit, but wish to avoid the confusion of two separate listings in the Master Schedule of Classes with different names for the courses. We would, upon approval of this proposal, ask the Registrar to stop listing the courses with zero credits in the Master Schedule of Classes.

b. Curricular effect: The change will not effect the curriculum. It is an administrative change to simplify registration.

3. Results of Consultation

The music department committee voted unanimously for the proposal.
