### **2. Rationale**

- a. The Department of Art has proposed a minor change to the Core/Foundation program for all students entering one of the degree tracks offered by the department. As part of this minor change, the department concluded that the titles of the Core/Foundation classes should accurately reflect the course content taught in those classes. The department believes that a change of course title will enable prospective and currently enrolled students to know the subject matter to be taught in each of these required courses. Secondly, these new course titles would be printed in the Schedule of Courses booklet, and will assist students to prepare schedules before meeting with an academic advisor.
