## NEW COURSE PROPOSAL: MUSIC THEORY IV- AURAL

### 1. Details:

- a. Course Title: Music Theory IV - Aural
- b. Sponsor: Dr. Lawrence J. Stewart, Music
- c. Credit Hours: 2
- d. Course Level: Sophomore
- e. Curricular Effect: Major requirement
- f. Prerequisite: Placement exam administered by the Music Department
- g. Time and scale of implementation: Spring 1997, two sections
- h. Adequacy of present staff and resources: Adequate
- i. Short-term evaluations: NA

### 2. Rationale:

The series of new course proposals Music Theory I-IV - Written and Music Theory I-IV - Aural are a proposed division of the present Music Theory I-IV into two separate but related series of courses. The division of the courses will enable the department faculty to give separate grades for different activities -- writing and aural (performance and dictation), and enable students with specific weaknesses to repeat courses in those specific areas of weakness rather than have to repeat a course with a larger curriculum.

### 3. Essence of the Course:

The objectives, content, evaluation and grading will be unchanged from the present Music Theory IV course except that the written materials will be deleted -- to be added to the Music Theory IV - Written course.

a. Course Objectives: This course is part of a four semester music theory sequence designed to provide the basic music aural skills needed by practicing musicians and music teachers. These skills include singing (using solfege), conducting, subdividing, rhythmic reading, and taking dictation of music. The music selected is for the purpose of practicing these skills and of demonstrating the subject matter listed in the topical content below. Students must have passed Music Theory III - Written and Music Theory III - Aural before taking this course.

b. Topical Content: 9th, 11th, and 13th chords; altered dominants, chromatic mediants, various post-romantic and 20th century techniques including 12-tone technique.

c. Evaluation and Grading Procedure: The final grade consists of three equal parts: final exam, mid-term exam, and daily grade. The daily grade is determined from attendance/class participation and quizzes.

d. Course Evaluation: Periodic assessments of the course will involve student evaluations, department curriculum review, and program review.

4. Results of Consultation: Unanimously approved by the Music Department Faculty on 10/19/95.
