MINOR CURRICULAR PROPOSAL: HEGIS NUMBER CHANGE FOR ORAL SPANISH COURSE

Details:

- a. 1. Change Requested: Change HEGIS number of Oral Spanish from 1105.205 to a 300 level course (1105.305)
- b. Sponsor: Dr. Anthony J. Robb

Rationale

- a. Statement of Need:

Prior to a HEGIS number change in Fall 1999, Oral Spanish was listed in the Course Inventory Scan of Spring 1980 under 2 HEGIS numbers: 1105305 and 1105205. The Department of Foreign Languages and Literatures requested on August 12, 1999 that only one HEGIS number be permanently used, 1105205 (See attached letter to Registrar). The change was originally made to be able to offer another lower level Spanish course due to the higher demand for the Spanish Minor at that time.

Given the recent changes in the renaming and realignment of Spanish program courses and their respective prerequisites, and in order to provide a sufficient number of Spanish electives at a higher level, a 300 level HEGIS number will better reflect the change in our program offerings, as well as the change in pedagogy. Specifically, in Fall 2004, the previously-named course, Intermediate Spanish II (1105211) was renamed Spanish Reading and Conversation to reflect national trends in Spanish Language course sequencing, as well as the Department's wish to focus more on oral production skills at the 200 level. Because of this recent change, the Department feels that restoring the 1105205 HEGIS number for Oral Spanish back to 1105305 will now allow students who continue into the major to take this course at a higher level. Finally, the prerequisite for Oral Spanish (1105205/1105305) has always been Spanish Reading and Conversation (1105211), previously named Intermediate II, and will not change.

- b. Curricular Effect:

Currently Oral Spanish is offered as a Spanish elective on a three-semester cycle. In addition to taking the required Group I (Spanish) and Group II (Spanish American) electives, Spanish majors are required to take a Spanish Program elective at the 300/400 level. The change back to the original HEGIS number will now allow students to use Oral Spanish (1105305) to fulfill this requirement.

- c. Changes in requirements:

Since this particular course is an elective, the change of HEGIS number and level does not affect any current requirements, but rather provides students with another elective option for the Spanish major.

It has come to our attention that the Oral Spanish course being offered this Fall two semester has the wrong hegis number (1105200). This hegis number is for Spanish Phonetics. In order to avoid confusion for our students, we would like to resolve this problem as soon as possible. According to the Registrar's Summary Statistics, Oral Spanish carries two hegis numbers. Please refer to the Spring 1997 Course Inventory Scan, and notice that Oral Spanish has 1105305 and 1105205 assigned as hegis numbers. We would like to have 1105305 hegis number deleted, final term and use 1105205 permanently.

In addition, the 1998/00 catalog lists Oral Spanish under the hegis number 1105912. This is also an error that requires correction.
