

Re: Deletion of courses, Title changes, and Prerequisite changes

1. DELETE THE FOLLOWING TWO COURSES:

2204.100 Elementary Economics, 3 s.h.

Rationale: The Dr. Robert Layer, the consultant for the Academic Program Review of the Department of Economics recommended deleting this course because the regular intro macro (2204.101) and intro micro (2204.102) courses would better serve the students from Professional Studies who generally take this course.

2204.225 Economic Roles of Women, 3 s.h.

Rationale: Dr. Layer recommended that topics from this course be included in the Labor Economics and/or Manpower Economics courses.

2. CHANGE THE TITLE OF COURSE NUMBER 2204.315:

Old: Economics of the Public Sector
New: Public Finance

Rationale: Dr. Layer recommended this title which has been the standard one for the past forty years in other economics programs.

3. CHANGE PREREQUISITES IN SIX COURSES:

Rationale: These prerequisite changes for all six courses strengthen the quality of the program and make the prerequisites of the upper level courses offered by the Department more uniform, appropriate, and consistent.
