Minor Curricular Change

1. Details
  - a. Change requested: Delete course 2204.204 World Economic History
  - b. Sponsor: The Department of Economics
2. Rational
  - a. The department is participating in the Association of American College's Reforming the Major Project. As part of the process, a consultant visited the campus on June 3, 1993 and recommended this course of action. The Department agrees.
  - b. World Economic History was approved as an elective course offering approximately 10 years ago. It was only offered one time, and, then, cancelled because of schedule exigencies. This is one elective course that should be pruned as it is impossible to effectively schedule. There does not appear to be much student demand for this course.
