2. RATIONALE

a. Statement of need for such a change:

Very infrequently full-time students enroll in the MBA program with the intention of receiving their degree within three semesters. In order to accomplish this it is often necessary to take Business Policy & Strategy simultaneously with one or two of the core courses. If students were not allowed to do this it could delay their graduation by a semester or even a full year, since Business Policy is generally offered only once each academic year. By including "Permission of Instructor" to the prerequisite list cases can be considered on an individual basis.

b. Statement of curricular effect:

There will be no effect on the curriculum.

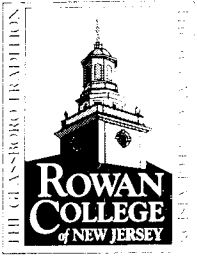


