MINOR CURRICULUM CHANGE to senior level number

I. Details

- A. Change requested: From current course number (0802.320 Children's Literature) to senior level number
- B. Sponsor: Ad Hoc Curricular Change Committee  
Department of Curriculum and Instruction:  
Elementary/Early Childhood Education

II. Rationale:

The course is highly related to classroom teaching experiences. We believe that this course is better taken by seniors (after a Practicum experience) than in its current sophomore level, particularly in the "new" program which expands the role of the Student Teaching experience.

It should be noted that the change would also permit enrollment by students in Post-Baccalaureate Achievement programs and graduate students (in programs with electives).

A. Impact on the Department Program:

None except for the teaching faculty who will expect differences in quality of student work, etc.

III. The Department has approved this change request.

Results of consultations with Dr. O'Day, Graduate Coordinator and Dr. Gallia, Chairperson of Secondary Education are attached.

(These consultations seem appropriate for the possible enrollment of graduate students. It is felt that our Department faculty is probably the major source of information regarding the program needs of our majors.)

Dear Marion,

The policy for requirements for the Master of Arts degree does allow for a maximum of six semester hours of upper-level (junior or senior) undergraduate courses, with the approval of the graduate students program advisor, department chairperson and Dean of Professional Studies, to be counted toward the 33 semester hour requirement. These courses must have been taken after the student received the bachelors' degree.

Since we already have two graduate courses in Children's Literature, 0802.510 and 1601.502, I'm not sure any students would be taking this course on the undergraduate level as part of a graduate program.

We do not, however, have a graduate course dealing with strategies for teaching elementary school academic areas through art, music, and dramatization. The undergraduate course Creative Experiences may be suggested by the graduate advisor as a possible elective which could be used in the graduate program.
