

a. Need: The Clarinet Choir has for three years been an informal ensemble serving Rowan College clarinet performers who are music majors or general students. The ensemble is chartered as an SGA organization under the auspices of the Bureau of Musical Organizations. It rehearses regularly and presents concerts each semester under the direction of Dr. Benjamin C. Christy, a full-time member of the music faculty. Music majors will be permitted to elect this ensemble, as with all ensembles of the Department of Music, to fulfill music ensemble curricular requirements, and general college students are encouraged to participate.
