2. Rationale

a. Statement of Need:

When Rowan achieved university status the faculty of the then School of Business Administration voted on a new name for the School with a "college" designation. It was the desire of the faculty to have the name "College of Business". The Board of Trustees, however, changed the name to "College of Business Administration" during the meeting when all Schools were changed to Colleges. At the regular meeting of the faculty on October 10, 1997, the faculty reaffirmed, by vote, their desire to have the name "College of Business".
