COURSE PROPOSAL

I. COURSE TITLE: Contrastive Analysis of Language and Culture

Course Description: The course will examine the linguistic and cultural phenomena essential to cross-cultural communication and understanding. It will be a practical course dealing with both verbal/linguistic and non-verbal communication.

Departments: Foreign Languages, Mrs. Mariel Ouni

Sponsor: Division of Liberal Arts and Sciences

II. ESSENCE:

- A. Course: Undergraduate
- B. Semester Hours Credit: Three (3)
- C. Course Level: This course is required for a Bilingual Education endorsement.
- D. Prerequisites: The prerequisites are to be determined by the Bilingual Activities Committee, Division of Professional Studies; which will act as a screening and advisory committee on an individual student basis.
- E. Position of the Course: This course is required in a bilingual education curricular pattern.
- F. Suggested Time and Scale of Implementation: Implementation of the course outlined in this proposal is to begin when the Division of Professional Studies receives approved program status of its bilingual program.

III. OTHER DETAILS:

- A. Present Staff: Members of the Departments of Foreign Languages
are qualified
to teach such a course
and resources are available to fulfill any specific
additional needs.
- B. Library Facilities: The program materials in the Savitz Learning
Resource Center are sufficient for such an
offering.
- C. Space Needs: Space is adequate.

- D. Uniqueness of the Course: This course is an essential component of the program of study leading to endorsement in bilingual education, and will emphasize and contrast modes of self expression.
- E. Specific Course Objectives: Emphasis will be placed on:
1. Contrastive studies of English phonology structure and syntax with that of the pupils dominant language.
 2. Contrastive studies of the English writing system with that of the pupils dominant language.
 3. Contrastive studies of various cultural aspects of "typical" American social patterns with those of the pupils dominant culture.
 4. Contrastive studies of non-verbal methods of communication with that of the pupils dominant language.
 5. General examination of non-academic variables which affect second language learning and cultural adjustment.

IV. RATIONALE:

- A. Fundamental assumption made in leading linguistic studies is that one of the most effective means of teaching language and culture, is through a systematic comparison of the pupils native language and the language that he/she is attempting to learn.
- B. This course, proceeding from the viability of such a basic assumption will deal, in practical terms, with such a systematic comparison, so that the teacher may gain insight into major areas of difficulty which pupils encounter in this regard. The course will also deal in philosophic terms with the effects of the dominant language and culture on second language learning and cultural adjustment.
