1. Details

- (2) Add Chamber Choir, Concert Choir, Opera workshop, Percussion Ensemble, Contemporary Music Ensemble, Guitar Ensemble, Orchestra, Lab Band *1 S.H. CR. D Act*

b. Sponsor: Tom Wade, Music

2. Rationale

- a. The current listing of music ensembles is not up-to-date: this corrects the problem.
- b. This expands the number of choices of ensembles for credit, either as free electives or general education.
