2. Rationale

A. Need

The new course title will allow us to avoid confusion with our newly approved course, Introduction to Literary Studies (ILS). ILS will be a required course for English majors; Introduction to Literature will continue to be offered as a general education elective. Renaming the course "Experiencing Literature" will help students distinguish it as a general education course distinct from ILS; furthermore, it will align it with similar general education courses in other departments, such as Experiencing Math and Experiencing Art.
