
RATIONALE: Although geology has traditionally been taught at Rowan through the Department of Chemistry and Physics, in recent years the faculty which taught these courses have left the University or retired. Two years ago, we began the process of transferring geology course from Chemistry and Physics to Geography and Anthropology, where a faculty member trained in geology has been hired. This transfer simply continues the process of moving geology into Geography and Anthropology, where the primary market for geology courses is to be found. It will make it easier for geography students to find the course in the schedule, and it will locate the course in the department where the appropriate faculty and resources are now housed.

The transfer will have minimal curricular effect. Geology I and II will be offered initially as general education laboratory classes, and as a service course for students majoring in civil engineering; they will later be integrated into the geography major program as options in the area of physical geography.

CONSULTATION: This change impacts only the two departments involved. Both the Department of Chemistry and Physics, and the Department of Geography and Anthropology approve of the transfer, as is evidenced by the sponsorship and signature of both department chairpersons.

REQUESTED ACTION: Approve moving the courses Geology I (1914-100) and Geology II (1914-101) from Chemistry and Physics to Geography and Anthropology: Geology I (2206-103) and Geology II (2206-104).
