

RE: Guitar Class Credit Hour Change

1. Title of the course - Guitar Class #1097.229.
2. Background - The Guitar Class was approved and listed in the catalog at least six years ago. At that time it seemed desirable to offer the course as an in-depth offering for three semester hours credit. The music department now wishes to make the Guitar Class consistent in scope and semester hours with the rest of our instrument classes (brass class, woodwind class, etc.) by reducing the hours from three to one per semester.
3. Essence - To reduce the credit hours for Guitar Class from three semester hours to one semester hour per semester.
4. Other Details - Staffing will be facilitated, Implementation and other details remain the same as the original course description. The depth of study will necessarily be less. The Music Department Faculty and the Music Department Curriculum Committee feels that the course will meet the needs of the students and Department more effectively if the above change is made.
