C. Rationale

Stunts in this course are limited to the lead-up skills recommended to be prerequisites for specific tumbling skills. Other elementary physical education stunts are covered in Gymnastics I - Movement Fundamentals as they related to floor exercise and basic movement, as well as in Curriculum and Instruction in Elementary Physical Education.
