a. **Change Requested:** The Health and Exercise Science Department is requesting the following:
change from two specializations

1. Teacher Certification in Health and Physical Education
2. Exercise Science with two separate tracks
 - Athletic Training
 - Adult Corporate Fitness (Proposed to be Health Promotion and Fitness Management)

change to three specializations

1. Teacher Certification in Health and Physical Education
2. Athletic Training
3. Adult Corporate Fitness (Proposed to be Health Promotion and Fitness Management)

2. Rationale:

a. Need: In 1996, the Department name was formally changed from Health and Physical Education to Health and Exercise Science. This name better reflects the changes in the focus of the course offerings along with the trends taking place in the various professions we represent. More recently, the department has decided to further refine our three "specialized" study areas. (The results of this work in the accompanying paperwork.)

Having the current specialization in Exercise Science with two sub divisions has been found to be confusing to students and outside observers. To better assist in the clarity of identification of the three tracks we currently offer, the formal development of three specializations is appropriate.

My understanding of Senate Curriculum Committee 9798-154 (attached)--Health & Exercise Science Department's Specializations--is that the name "Health Promotion and Fitness Management" was part & parcel of the creation of the third specialization, and thus does not require a separate proposal to instantiate the new name. "Adult Corporate Fitness" was the first name listed on the third specialization only to draw the parallel with the previous **track** under the Exercise Science specialization.
