We are proposing to delete the prerequisites now listed for Laboratory in Personal Training Techniques(Hegis# 0837.329.01) and add the following pre- or corequisite: Exercise Prescription (Hegis# 0835.401)

Details:

Laboratory in Personal Training Techniques (Hegis # 0837.329) is a laboratory course designed to accompany the course, Exercise Prescription (Hegis# 0835.401). Presently the catalog identifies the wrong prerequisite for this course. To correct the present error we would like the designation to be changed as charted below.

Rational:

Laboratory in Personal Training Techniques is meant to be a laboratory for the course Exercise Prescription. We incorrectly designated Exercise Physiology (Hegis # 0835.344) as one of the prerequisites for this lab when actually Exercise Physiology with a Lab. (Hegis # 0835.345) should have been a designated prerequisite. If we were to correct this error simply by changing the present prerequisites from:

we would be listing the prerequisites for Exercise Prescription (Hegis # 0835.401). Since Laboratory in Personal Training (0835.329) is meant as a complementary laboratory for Exercise Prescription it is reasonable to simply designate Exercise Prescription as a pre- or co-requisite for the course.
