Minor Curricular Change

1. Details

- a. Change Title from Language Development and the Language Arts Curriculum to Language Arts -- Preschool Child
Change Credit hours from 4 to 3

2. Rationale

- a. The course title has been changed to conform more closely to the course content modification that will result from the semester hour credit reduction. All Early Childhood course titles have been changed for conformity and simplification purposes.

Credit change is requested in order to permit the Early Childhood program required course credit total to conform to the proposed Department of Curriculum and Instruction Teacher Education Model which has been designed to meet new State guidelines for teacher education programs.

Such change is mandatory if the Early Childhood program is to qualify for approval by the State Department Teacher Education Certification agency.

- * b. The curricular effect will be to reduce course content both in scope and depth accordingly with credit reduction.

3. Consultation

The credit reductions have been determined in conjunction with Early Childhood faculty Jean Carl and Larry Gurst.

- * Laboratory experience (observation time) will be reduced to accommodate credit reduction.
