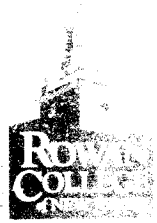
MINOR CURRICULAR CHANGE: 1009. 401 Senior Exhibition

### 1. DETAILS:

1. Change requested; From letter grade to Pass/No Credit
2. Department of Art Faculty

### 2. RATIONAL:

- a. Each art major is required to prepare and mount selected works as a senior exhibition. The art exhibited is done in the art major studios under the instruction and supervision of a faculty member and is given a letter grade. There seems to be no need to have the works graded again in the senior exhibition.  
Further the senior show is done to give the art majors an opportunity to see their work as a visible portfolio, experience in selecting and presenting a body of art work and as a showcase for our art major program. More than half of National Association of Art and Design member schools do not grade senior shows.
- b. This change will not effect the program.
