Change of prerequisites for Supervised Internship in Accounting (0502.400) from Intermediate II to Accounting II (0502.211) (permission of internship supervisor).

2. Rationale:
  - a. Statement of "Need" for Such a Change:  
By having Intermediate II as a prerequisite, it precludes Junior Accounting majors taking the Internship course.
  - b. Statement of Curricular Effect:  
This change will strengthen the accounting major by allowing more of our students to take advantage of our internship program.
