Contractual Agreement

This contract is a binding agreement between the student and the Office of Residential Learning & University Housing. It is in effect for one semester (January 2012 - May 2012) for new students entering in Spring 2012 and for two semesters (August 2012 - May 2013) for new students entering in Fall 2012.

Students who wish to cancel their housing assignment, and live off-campus, must make a formal request to terminate their housing assignment. The request to cancel the housing assignment contract must be reviewed by the Assistant Director of Housing. Approved cancellations will be subject to a \$500 cancellation fee and the loss of the \$200 security deposit.

University policy requires all freshman applicants to live on-campus for two years and all transfer applicants to live on-campus for one year.
